PRIA (PESTICIDE REGISTRATION AND IMPROVEMENT ACT) THE CONFERENCE REPORT FAILED TO INCLUDE RE-AUTHORIZATION OF PRIA

WOTUS (WATERS OF THE U.S.)

CURRENT PROPOSAL STATES THAT ORDINARILY DRY CHANNELS WHERE WATER FLOWS OCCASIONALLY OR INTERMITTENTLY DO NOT CONTRIBUTE TO A TRIBUTARY.

# Labor:

CALIFORNIA: EMPLOYEES AT FARMING
OPERATIONS WITH MORE THAN 26 EMPLOYEES WILL
RECEIVE OVERTIME AFTER A 9.5 HOUR WORKDAY
IN 2022, OVERTIME AFTER A 8.0 HOUR WORKDAY

#### Observations:

STATES WANT MORE BUY-IN IN DECISIONS REGARDING NUISANCE PESTS, PLANTS, ETC.

STATES WANT FEDERAL/STATE RELATIONSHIPS IMPROVED UPON REGARDING ENDANGERED SPECIES, ETC.
