## FROM THE PRESIDENT

This held true across the United States. All states were having the same issue.

As 2023 moved around, the same issues are still here. Fertilizer prices seemed to level off and demand lowered a bit. But the drought was still a concern. Consultants were the saving grace. Having an independent crop consultant on your team is valuable. As a grower, I value the assistance the consultant gives me with looking at the changes in the laws, researching the correct tools, and making sure I have the right product at the correct rate and at the right time.

Who knows what 2024 will bring us, but I am glad that I have a consultant on my team to help me navigate my way through the rough roads. I know California is supposed to have an El Nino year, so let's see what Mother Nature throws at us. There is not anything we cannot do. My father always said the farmer is not just a farmer today; he or she is a scientist, a computer expert, an engineer, a mechanic, a mathematician, and sometimes a psychiatrist. We just have to have the correct tools, and I feel one of the correct tools is having an agricultural advisor assist you.

## HAPPENINGS ON THE HILL

### **Hill Action**

By the time you read this update, the NAICC annual meeting will be well underway, with January 2024 almost half over. The House and Senate have consumed their first days of January in a search for a viable path to keep the government open and functioning, given the looming January 19<sup>th</sup> expiration of four FY'23 appropriations bills and the February 2<sup>nd</sup> expiration of the remaining eight bills.

At the time of this writing, a top-line amount for another continuing resolution (CR) has been agreed to, sort of, depending on who you ask. Because neither party has an interest in a shutdown, I believe there will be an agreement on a CR with a March expiration date to give the Appropriation Committee's staff the 4-6 weeks they will need to wrap up negotiations on the individual spending bills. Otherwise, rules contained within the Fiscal Responsibility Act of 2023 mandate an across-the-board 1% funding cut, which defense hawks and others will never let happen.

So how does this Appropriations timing impact the next Farm Bill? Chairman Thompson, at last week's Pennsylvania Farm Show, said that March is the soonest he will be able to get legislation to the floor. His statement includes at least three weeks for the Committee's action in noticing the bill, marking it up and passage out of the Committee.

But here is where it gets tricky. Because floor time is such a precious commodity in both House and Senate, do not be surprised if the CR vote compresses the House's March floor schedule. Keep in mind that Mr. Thompson will not want to go to the floor with a Farm Bill until the CR votes are well in his rearview mirror.

Further, with the '24 Presidential campaign kicking into high gear within the next few weeks, I cannot see any major floor action in the House after March, so Mr. Thompson's floor window is narrow and may close before he can get the bill to the House floor. Finally, with a new CBO Farm Bill baseline due in May, the calendar does not appear to be friendly to Mr. Thompson and his staff. The new baseline would require a time-consuming reexamination of the assumptions within the legislative text to ensure consistency between the two.

## **Regulatory Update**

EPA prieted both House and Senate Ag Committees on the status of PKIA v implementation this week. In discussions with those attending, I conclude the biggest takeaway from the briefing is that while the agency has made solid progress in boosting FTEs from a low of 494 to 563 currently, that number remains about 40 FTEs short of FY'22 staffing levels.
