#### HAPPENINGS ON THE HILL

Mid July 2024 finds me thinking of the adage, "there are decades where nothing happens; and there are weeks where decades happen". Last Saturday's attempted assassination of former President Trump has caused not only a deep, if momentarily, national introspection of how the country arrived here but also set into motion an ascending Republican Party with Democrats finding themselves in an increasing disarray since President Biden's shaky performance in the first presidential debate.

At the timing of this writing, it is appearing more likely than not that President Biden will drop from the ticket, setting the stage for a possible open convention when Democrats meet in Chicago on August 19-22.

Any speculation on what the current state of the two political parties means for agricultural policy would be meaningless at this point. But other actions emerged in late June - early July that will have significant near and long-term impacts on agriculture, particularly in regulatory settings.

#### **Supreme Court**

On June 28, the Supreme Court overruled the so-called "Chevron" doctrine in issuing its decision in *Loper Bright Enterprises v. Raimondo*. Chevron required federal courts to defer to administrative agencies' interpretations of their governing statutes in cases where those statutes are ambiguous.

Over time, conservative legal theorists increasingly argued that Chevron provided an unfair legal advantage to agencies when defending their rulemaking in courts.

In overturning Chevron, environmental law firms such as Beveridge and Diamond believe the U.S. Government may now use a 1944 case, "Skidmore "in lieu of Chevron arguments as Chief Justice Roberts referred to Skidmore five times in his Loper Bright opinion. At its core, Skidmore provides that judicial deference to an agency's interpretation only rests on the agency's "power to persuade."

With the Roberts court move towards deregulation and judicial branch consolidation of authority firmly in place, the regulated community will find itself confronted by both challenges and opportunities in this new legal landscape.

#### **Congressional Actions**

EPA was the focus of two House of Representative hearings in July. The first on July 10, found the House Oversight and Accountability Committee receiving testimony from EPA Administrator Michael S. Regan. In the hearing, a line of questioning emerged on the impact of potential staff reductions, relocations, or eliminations on pesticide registrations. To those questions, Administrator Regan made it clear that if those actions

were to happen, delays in moving new pesticides to market will occur significantly hurting agriculture.

On July 11, the House Committee on Agriculture held "Examining the Consequences of EPA's Actions on American Agriculture" where four witnesses provided a grower/producer perspective. Testimony and member questions addressed issues surrounding FFRA, PRIA, PFAS and ESA. Witnesses and members advocated that on especially on pesticide issues, early consideration of USDA's perspective and input from its Office of Pest Management Policy would be invaluable to the EPA regulatory process.

#### **Agency Actions**

On July 8, EPA announced an update to the level at which atrazine could adversely affect aquatic plants as well as fish, invertebrates, and amphibians. The new revised atrazine concentration of 9.7 micrograms per liter (µg/L reflecting exposure modeling corrections and public comment. This action may make it easier for growers to use the herbicide.

On July 15, EPA announced new spray drift protections. More on that can be found here.

#### Farm Bill

Agriculture interests will engage in a late summer full court press for a 2024 calendar year Farm Bill passage. Do not be surprised when another extension rides with an expected September continuing resolution to fund the Federal government.


