FROM THE PRESIDENT

The following is an article written by James Todd for the NAICC News. I would like to express my thanks to James and his committee members and highlight the excellent work they have done on behalf of NAICC by making this the President's Column for May.

This year's Crawfish Boil was a great success. Our good friend Tim Ford did an excellent job preparing the crawfish and feeding over 300 staffers and congressmen. Twenty NAICC members and staff played host to the attendees. It was a great time to interact with key people in Washington and

provide a relaxing atmosphere for the staffers as they prepare for what will be an extremely important and busy congressional session.

This year during our visits, there was one issue that came up in almost every meeting and is no doubt the most important issue in agriculture right now. This issue is the Endangered Species Act and critical habitat evaluations. EPA is required to evaluate the impact of pesticide use on critical habitat for endangered species. EPA is directed to work together with US Fish and Wildlife (FWS) and the National Marine Fisheries Service (NMFS) to evaluate potential impacts on these endangered species. For many pesticides, this evaluation has never occurred, and EPA has its hands full completing these evaluations so that reregistration can occur.

NAICC is particularly concerned with how these evaluations and subsequent mitigation measures will affect many of the pesticides we use. NAICC members are battling resistance to pesticides on many fronts and are concerned about losing many important tools to fighting resistance. However, NAICC believes that our clients are willing and able to help preserve critical habitat as it relates to endangered species. The modern farmer has so many tools available to him with today's advanced technology to aid in ensuring pesticides go where they are intended to; and implement conservation practices to help reduce run off further ensuring these pesticides stay where they were intended to be.

For these reasons, NAICC is preparing to conduct a pilot project to demonstrate the ways growers can showcase these mitigation techniques all while helping to preserve critical habitat. Many farmers will view having critical habitat for endangered species as an asset. EPA commented on how encouraging it was to hear that and that they did not hear that when talking to other stakeholders. Our government affairs-crop consultant sub-committee chairman, Steve Hoffman is heading up this project. Steve is looking for partners in this project as NAICC goes forward. A team of NAICC members made a return trip to DC in early May to shore up support for this project. EPA's interest was definitely peaked, and we spent time going over various scenarios and ways to accomplish the task at hand. We have several calls with EPA and other stakeholders this week to put the final touches on our proposal.

As another follow up to our March visits, team members that made the trip in May met with USDA-NRCS officials to discuss the potential changes to the Technical Service Program (TSP) to make it more streamlined and user friendly. We also discussed renewing the MOU with NRCS for NAICC's Certified Professional Crop Consultant program to submit names of qualified TSP to NRCS. The team consisted of Ian Olson, Stan Winslow, Jim Steffel, Keith Jones, Allison Jones and me.

Here are the NRCS is currently working on to streamline the TSP process:

- Updating software to a new platform 2024 completion date
- Making it easier to share information they are working on incorporating other software used in the field to up uploaded grower/plan information to the TSP site.
- Looking at requirements to see if they are appropriate or overly burdensome.
- Considering using NRCS templates to write the plans.
- NRCS is looking at payment rates and plan to reconfigure them.
- They hope to increase TSPs by 60% including 3000 to 6000 new NRCS employees within 3 to 4 years with money from the Inflation Reduction Act Funds.

The team met with staff of two Congressmen who introduced bills to help streamline the TSP process as well as staff of the House Committee on Agriculture.

We live in a time where agriculture has a great story to tell, and we look forward to opportunities where NAICC can help tell this story.

HAPPENINGS ON THE HILL

This month's edition begins with a shout-out to the Congressional Budget Office (CBO), its outsized role in budget negotiations, and its ability to grab attention in policy debates from debt ceiling to Farm Bill. We start first with CBO's Friday, May 12th, statement saying that "if the debt limit remains unchanged, there is a significant risk that at some point in the first two weeks of June, the government will no longer be able to pay all of its obligations."

CBO, not to be content with a single Friday announcement, also updated its Farm Bill baseline on the 12th. The upshot was that both farm and nutrition costs rise, making the Farm Bill, over the life of the 10-year CBO baseline, more expensive than previously estimated. These new numbers have caused some Farm Bill watchers now to believe that a debt ceiling deal that includes reductions in the cost of nutrition programs as all but inevitable and might prove to be useful in smoothing the road for the next Farm Bill by removing the most contentious item within its debate.

However most importantly, on Friday, I represented NAICC in the joint USDA/EPA crop protection stakeholder meeting on EPA's use of NRCS practice standards as mitigation tools under EPA's ESA workplan.

The meeting, hosted by Robert Bonnie, USDA Undersecretary for Farm Production and Conservation Programs, and Jake Li, EPA Deputy Assistant Administrator for Pesticide Programs, was designed to be the first in a series of engagements with commodity groups, applicators, registrants, retailers, and crop consultants on the wisdom of using NRCS practices as mitigation tools, and, if used, how best to communicate with growers, many of whom have limited knowledge of NRCS practices.

Broad themes emerging from Friday's discussion included:

Establish Essential Ground Rules

- NRCS must not be a regulator. (USDA and EPA fully concurred)
- Focus must be on the practices themselves and not EPA's program needs. (Again, EPA and USDA concurred)

Rationalize and Expand Practices

- Practices must be applicable and adaptable to all regions, geographies, cropping systems, and weather (rainfall).
- EPA must fully consider practice options beyond NRCS (State and private).
- EPA should consider the adoption of a mitigation grower credit when practices are used.

People Needs

- NRCS must recognize its staff limitations and be innovative in building capacity.
- NRCS must streamline the TSP process and recognize the role of crop consultants in producer communication.

Validation

 NRCS grant programs such as RCCP should be considered to establish pilot projects to ground truth practice adoption and effectiveness.

My overarching takeaway from the joint meeting is that crop consultants are well positioned in this multi-agency conversation. As I suggested to the assembly on Friday, independent certified crop consultants should be seen by EPA and USDA, as translators of complex, foreign languages, in that we can bridge and translate communication from a large swath of interested parties within our sphere of influence.
