One of the highlights of the meeting is our Emerging & Evolving Technology Session. Our industry partners, and individual members may showcase new crop protection products under development, new uses of current chemistries, as well as new equipment and software.

The 2022 consultant sessions will include topics such as carbon markets, labor issues, the future of crop consulting, electronic technologies, and data management. HAPPENINGS ON THE HILL

EPA Issues Final Rule to Revoke Chlorpyrifos Tolerances

On August 18, 2021, the Environmental Protection Agency (EPA) announced that it will stop the use of the pesticide chlorpyrifos on all food crops. EPA is taking these steps in light of a court opinion concerning chlorpyrifos uses and compliance with the applicable regulatory standards. EPA is doing so by revoking all food tolerances for chlorpyrifos. This final rule is effective October 29, 2021. The tolerances for all commodities expire on February 28, 2022.

One concerning point of this action is that by EPA's own admission, although all chlorpyrifos food tolerances would be revoked, there would still be a number of food uses that continue to meet all safety standards even after applying EPA's most stringent regulatory criteria. Nevertheless, EPA's action would revoke tolerances for all food uses even where, in certain crop production areas, use could still be allowed, including alfalfa, apples, asparagus, cherries, citrus, cotton, peaches, soybeans, strawberries, sugar beets, and wheat.

The most concerning aspect of the chlorpyrifos cancelation is that EPA followed the decision of one court verdict instead of its own science-based evaluations of the compound. This could set a dangerous precedent making future registrations tentative until a court has ruled on them.

It appears that chlorpyrifos can be sold and applied and the resulting crop sold as long as there were tolerances in place at the time of the sale/use. Unfortunately, most of the ag applications would take place after the expected tolerance revocations of February 28th. Also, EPA will review non-crop uses after they are finished with the food uses.

Neonicotinoid Biological Evaluations

The current registration review of clothianidin, imidacloprid and thiamethoxam includes going through the Endangered Species Act's (ESA) Biological Evaluations (BEs). These reviews are done by the federal EPA and the Fish and Wildlife Service to determine whether a product may affect one or more individuals of an endangered species or their designated critical habitat.

Rod Snyder named EPA Ag Advisor

The Environmental Protection Agency has named Rod Snyder its new Agriculture Advisor. Snyder comes to the agency after serving as president of Field to Market. He will lead outreach and "engagement efforts" with the ag community and EPA. It is also reported that he will work to advance the Biden-Harris environmental agenda for farmers and rural

Bumble Bees

Federal Fish and Wildlife published a 90-day finding on Bumblebees and is going to do a status review whether or not they should be on the threatened or endangered species list. A petition filed with the agency says that the pollinator's population has dropped by nearly 90% over the past 20 years and is no longer seen in eight states.

The agency will assess the status of the American bumblebee over the next year and is asking for any data that might be out there. The petition was filed, in part, by the Center for Biological Diversity. The petition says habitat loss, pesticides, disease, climate change and competition from non-native honeybees are the reason for their decline.

ESA Biological Evaluations

Crop Life America took a positive step and co-hosted a workshop on Biological Evaluations with the Defenders of Wildlife. The workshop included key stakeholders from ag and NGO's. They were looking for areas that both sides can agree on and what success would look like. I'm not sure that a lot of common ground was found, but it was productive enough that they hope to follow it up with something similar where agencies could be involved.

Pesticide Registration Improvement Act

The next PRIA isn't due until 2023 but work still continues under the current PRIA. A PRIA funding increase has recently passed out of the House into the Senate. The key issue driving this is that EPA continues to miss deadlines in the registration process.

Waters of the U.S.

EPA is backing away from the WOTUS reforms that were put into place under the Trump administration and is backing up to the 2008 guidelines. Circuit courts in New Mexico and Arizona both threw out the 2020 WOTUS regulations. The EPA concurred that the court orders applied nationwide, making this an easy out for the agency. It is another example of allowing legislation through the court system.

ANNUAL MEETING SURVEY RESULTS

Based on the feedback from the recent annual meeting survey, there are mixed emotions on whether or not to attend the meeting in Orlando. We are continuing to plan an in-person meeting at this time, and hope you will join us.
