FROM THE PRESIDENT

What's Your VALUE?

At times, being a consultant in the Ag industry can be a frustrating. One of the challenges we face in our industry is the perception of value and the battle between where we value our services and where our clients value our services. Often times, we assign a value that is too low. No time is this evident than when I see posted rates for mechanic shops. I walked into a shop last week that listed its rate at \$150 per hour.

I find this frustrating when I think of the years of education and experience that members of our industry hold. I hear it's a struggle to charge half or three quarters of the value we perceive that we offer because of the fear that the client won't pay and we will have no work or because we are too humble to reasonably value our services.

I spoke with a local crop consultant who mentioned that he has one client who he sits down with each winter and reviews the performance of his blueberry fields. He said that rank each field on yield performance and other factors such as drainage and soil type. They discuss the impact of what's actually working within the field efficiently. Then, the grower decides whether to keep the lower ranked field for another season or sell off a property to start fresh with a new one. Often times, a "for sale" sign goes on the property. He said that this grower's philosophy allows him to get rid of the problem properties, focus his energies on the better performing field and not strain his labor and equipment resources.

The same consultant recently told me that he is now implementing this same philosophy with his business as he approaches retirement. He has started to drop farmer-clients who give him the most headaches. In turn, he is able to better serve clientele he has retained, provide more time to them, work less and charge more. He said he wishes he would have done the years ago!

As we exit the field season and move into the fall and winter months, now is the time to reflect on the value you bring to the table and think through where the past season's hardships have come and have impacted your standards. By doing this you may find that you're undercutting yourself and that a change may be in order to get back to where you need to be.

USDA Announces Grant Opportunities

Conservation Innovation Grants (CIG) Classic - October 11, 2022

USDA's Natural Resources Conservation Service (NRCS) will invest \$15 million in conservation innovation this year through the Conservation Innovation Grants (CIG) Classic program. CIG is a competitive program that supports the development of new tools, approaches, practices, and technologies to further natural resource conservation on private lands. Through CIG Classic, partners develop new tools, technologies, and strategies to support next-generation conservation efforts on working lands and develop market-based solutions to resource challenges.

RCPP Nutrient Management Grants - October 31, 2022

USDA's Natural Resources Conservation Service (NRCS) announced funding to improve opportunities for nutrient management. This is part of USDA's broader effort to address future fertilizer availability and cost challenges for U.S. producers. This announcement includes new flexibilities for nutrient management practices and planning, an economic benefits outreach campaign, and expanded nutrient management capacity. This includes a streamlined funding opportunity for up to \$40 million in nutrient management grant opportunities through the Regional Conservation Partnership Program (RCPP).

All projects must further our mission, which is to foster the development and adoption of Integrated Pest Management (IPM), a science-based approach to managing pests in ways that generate economic, environmental, and human health benefits. Funding is outcome-based.

Deadline for Proposal Submission Friday, November 18, 2022, at 5pm EST

Funding Categories

Seed Projects; Capstone Projects; and Working Groups (New or Continuing)

Funding Amounts

Targeted total funding for all Seed, Capstone, and Working Group projects is \$250,000. Most projects are limited to \$30,000 although in special circumstances IPM Working Group proposals may qualify for up to \$40,000 per proposal.

Timeline

The review panel for Southern IPM Grants sits in mid-January to make decisions regarding the funding of proposals. Applicants will be notified in a timely manner so projects can begin on March 1, 2023.

Father and Daughter Team

Research became a second career for Jessie Roeth.

Preaching to the choir here: we all know crop research is an important occupation and one many people who grow up on farms feel will be a great fit for them with loads of fulfillment. Jessie Roeth, however, took a different path getting into the field (pun intended). Although her dad was a corn breeder for a major agrichemical company for more than two decades while running the family farm, the company closed his research station down and his only option was to transfer to a position out of state.

Moving wasn't an option. The family had farmed in the Troy, Ohio area for close to 100 years. So, he reinvented himself.

That's when he founded Buckeye Ag Testing.

Jessie had no intention of joining her dad's work prior to Buckeye being established. She had grown up on the farm, been a 4-H kid, but pursued sports more than anything else.

"I went on to play college basketball and then I coached college basketball for three years," she says.

It was when Jessie went back to school to earn her master's degree in business administration at The University of Findlay that she began to see a need at home. Her dad needed help with the business, especially in the administrative and finance areas, yet Jessie had no prior experience in ag research. She joined Buckeye Ag Testing in 2007 and hands-on learned the business with a crash course in the agriculture research side taught by her dad on site.

The family farms about 900 acres in corn, soybeans and wheat with about 350 acres dedicated to various research projects.

"He's still involved, but he's living the semi-retired lifestyle now," she says of her dad. "We have an excellent staff of 9 full time employees here. And this summer, we had six college interns."

Add to that 15 to 20 part time workers who come in during the growing season and there's a lot going on. Everyone has their strengths, but they all are willing to jump in when and where it's needed.

Yet, with all that happening, some things remain constant. The family business stays close to its roots and offers testing in corn, soybeans and wheat. However, what testing they offer in those crops is flexible.

"Buckeye started out just doing some variety trials, but every year, we started to expand our equipment, expand our testing," Jessie says. "We've been very flexible about meeting the needs of whatever trials come in. The ability to diversify in this business has been very important."

Diversification, with a focus on the crops they know best, allows them to be specialists in variety trials for those three crops while meeting the specific needs of clients.

"I found I really like having a balance of inside work and outside work," she says. "You don't really have time to be bored, there's something different every day."

Obviously playing sports competitively means Jessie is a competitive person. She wanted to do a great job at Buckeye, so she threw herself into it.

Madeline Mellinger Named Florida's Woman of the Year in Agriculture

Florida Commissioner of Agriculture and Consumer Services Nikki Fried and the Florida Department of Agriculture and Consumer Services (FDACS) announced Madeline Mellinger as the 2022 Woman of the Year in Agriculture.

"It's an honor to announce Madeline Mellinger as this year's Woman of the Year in Agriculture," said Fried. "Madeline has dedicated 50 years to Florida's agriculture industry and is an innovator in the field of integrated pest management. As a business owner, scientist, and mentor, she has contributed greatly to the development of Florida's next generation of growers and our agricultural industry as a whole. We are thrilled to be able to celebrate her with this award."

In 1972, Madeline Mellinger founded Glades Crop Care, Inc. and remains its CEO today. Glades Crop Care is an independent agricultural consulting and contract research firm that provides integrated pest management and crop counseling services to more than 65,000 acres of plants and over 60 varieties of fresh vegetable crops, citrus, rice, and sugarcane.

Mellinger's work has changed the way farmers in Florida approach pest control. Her work showed producers that they could shift from calendar-based pesticide application to need-based, which saved farmers money and reduced negative agricultural environmental impact.

Mellinger has also dedicated her time throughout the years to serving on a number of IFAS-related advisory boards, including the UF/IFAS Everglades Research and Education Center, a vice president search committee and co-chaired the UF/IFAS Strategic Planning Committee. In addition, she and her husband, Dr. Charles Mellinger, were vital in the establishment of the Doctor of Plant Medicine Program at the University of Florida to educate Florida's future agricultural innovators. Madeline has been repeatedly recognized for her service, including being named a Friend of IFAS in 2014 and was one of Florida Trend's Living Legends for 2018-2020.

SUPPORT NAICC BY SERVING ON A COMMITTEE

President Elect Clark Poppert will soon begin appointing committee members for the 2023 NAICC Committees. This is a great way for you to get involved in NAICC and support the Alliance. Each committee is comprised of a Committee Chairperson appointed by the President (occasionally two people act as co-chairs); committee volunteers are from the membership; and the President appoints an Executive Board Liaison for each committee. The role of the Board Liaison is to sit in on committee meetings when possible and to function as the point of contact between the Committee Chair and the Executive Board. A few committees also have sub-committees within their structure, and for the most part these subcommittees also have a Chair that functions the same way, but typically report to the larger oversight committee (details below).

All committees meet on Wednesday afternoon at the Annual Meeting with the exception of the Allied Industry Committee which meets on Friday morning. Most committees conduct their business via email but conference call meetings throughout the year are available. Any member in good standing can serve on any of the other committees.

Here is a brief description of each committee to help you decide where you would like to serve:

Allied Industry Committee is made up of eleven elected Sustaining Members and two Voting members, (appointed by the President). The purpose of this committee is to recommend ways that NAICC and industry can work more closely on projects they have in common. This committee also identifies areas of mutual concern and provides an avenue of communication as well as evaluates papers for the Emerging Technology Session using the current criteria and specifications.

One of the most vital committees is the *Annual Meeting Coordination Committee* (AMC) tasked to plan, coordinate, and find speakers for the program of the next annual meeting, with input from the Consultant Education (CEC), Research Education (REC), and Quality Assurance Education (QAEC) subcommittees. This committee is chaired by the President-Elect.

The *Certification Board* is appointed by the President and finalizes, administers, and modifies the NAICC Certification program as needed.

An integral part of NAICC and the Executive Board decision-making process is from information coming from the *Governmental Affairs Committee* (GAC). It is made up of three subcommittees: GAC-Crop Consultant (GAC-C); GAC Researcher & QA (GAC-R), and the Crawfish Boil on the Hill (CBOH). The GAC monitors and discusses legislation and regulatory issues and policies, pending, proposed, and needed, specifically those that will directly impact NAICC members, but also general agricultural, environmental and food

issues on which NAICC may be consulted or wish to express an opinion. The committee assists the Executive Vice President and provides information to the membership through newsletter articles and emails and identifies issues and develops talking points for the NAICC Board prior to Hill visits.

The *Crawfish Boil on the Hill* (CBOH) subcommittee plans the annual CBOH event to be held in conjunction with the March Executive Board meeting in Washington, DC. NAICC hosts Congressmen, Senators, Congressional staff, USDA, EPA and other agency personnel, as well as invited commodity and Ag association groups/ representatives for an evening of good food and networking opportunities.

The *Education Outreach Committee* (EOC) has four subcommittees: Consultant Education, Researcher Education, GLP Education and ACADEMY Subcommittee. They are responsible for developing educational opportunities for members outside of the annual meeting. Currently these subcommittee are responsible for planning and promoting the Focus on Ag workshop, Efficacy Training and the GLP Training course, webinars within the ACADEMY, and other regional workshops held annually.

Although it is seldom needed, the *Grievance and Ethics Committee* (G&E) reviews any grievances that one member may file against a fellow member and if necessary, submit any recommendations stemming from a review to the Executive Board. They also periodically review the NAICC Code of Ethics and recommend updates as needed.

The *International Outreach Committee* works to establish contact with other consulting organizations outside of the U.S. and to look for opportunities to cooperate on educational programs and information exchange. They assist in keeping NAICC informed of agricultural issues facing consultants in other countries. This committee also acts as liaison to the Global Alliance of Independent Crop Consultants.

The *Leadership Program Committee* is responsible for developing and implementing certain portions of the NAICC Leadership Program (NAICCLP).

The committee responsible for marketing the association to sustaining members and current membership is obviously called the *Marketing Committee*. This committee is also responsible for the Consultant of the Year award program and reviewing the NAICC website, NAICC.ORG for needed updates.

Responsible for recruitment of new members as well as periodic examination of the eligibility of all members is the *Membership Recruitment, Retention, and Rules*Committee or the MRR&R. Members also head up the New Members Boot Camp held at the Annual Meeting and act as a liaison to new members during their first two years of

membership. The committee consists of one Executive Board Directors plus a minimum of three other appointed members.

The **Newsletter Subcommittee** is under the jurisdiction of the MRR&R. This committee works with the Executive Vice President to source and accumulate articles for the NAICC News that are of interest to the membership and current events in crop and research consulting businesses and in agriculture.

One of the most important committees is the *Nominating Committee*. This committee's mandate is to nominate qualified NAICC voting members for election to available positions on the Executive Board in all sections with the exception of the Director position to be held by a person from any membership category other than the Voting Membership category, hereafter called non-voting position.

According to NAICC by-laws, the current past president serves as the Chair of the nominating committee. The NAICC president-elect also serves as a member of this committee. The President Elect will select two NAICC past presidents to serve on the committee. Finally, a minimum of four voting members are nominated to the committee from the floor at the annual NAICC business meeting. At least two of those nominated from the floor will reside east of the Mississippi river and at least two will reside from west of the Mississippi river.

THREE PRE-MEETING WORKSHOPS

Pre-Meeting Workshops

GLP Training

Randy and Angela Fuller (*IntegriQual LLC*) and GLP Education committee co-chairs, invite you or your staff to the upcoming GLP training sessions offered on Tuesday, January 24th at the Omni Nashville Hotel. Sessions include:

GLP Basic (limited to 100)

GLP Refresher/Advanced (Limited to 60)

Practical Field – Sampling (Limited to 25)

These courses are designed to address GLP knowledge and application for basic research staff (lab & field), study directors, principal investigators, and test facility management. Basic GLP is an introductory, all-encompassing overview of the regulations taught by Lori Rodaway, Annette Leslie, and Angela Dawson. This is recommended for newer staff, both technical and QAU.

Advanced GLPs are taught by Randy Fuller and Mark Tumey. "We cover more practical aspects of GLPs in real life situations and have done detailed discussions on things like the EPA advisories and GLP preambles in the past," said Randy. This is course for QA, TFM and SDs who want a better understanding of GLP principals and problem solving.

Finally, the practical workshop gets attendees out of the classroom and into the field (or parking lot) to have hands on demonstrations of various techniques and equipment, as well as discussions on maintenance, GLP documentation, and Standard Operating Procedures. "This is a good fit for those working in the field to learn sampling techniques and equipment firsthand," added Randy.

Sessions are held concurrently. The investment is \$125/person/course. According to Randy, "Space is limited so I recommend visiting the NAICC website. When registering for the Annual Meeting, choose the class under additional workshops. If there is space available the day of, we may be able to register a few more people at the door." All workshops are on Tuesday lasting about 4 hours, starting at 8:00 am and usually breaking up by 12:00 noon. These qualify as CEU for RQAP certification.

Consultants Workshop

Navigating the Surge of Biological (Biostimulant) Product Introductions into Crop Production Markets.

During the past decade there has been an increasing number of biological based products, biostimulants and biopesticides, introduced into local and global agricultural markets to support improved plant and soil health, and pest management.

Documenting label claims for efficacy in small plot studies and understanding the value of these products in commercial production systems presents a challenge for researchers and crop advisors.

In this GAIAC/NAICC Workshop speakers (agricultural advisors, researchers, industry representatives and regulatory officials) will discuss the challenges presented in generating and communicating the supporting data and economic value of these products. The workshop purpose is to help advisors make informed recommendations to support grower client decision making.

Speakers and participants will explore potential for collaborative strategies between researchers (public and private) and advisors to develop reliable large-scale data to better assess the performance and value of these products in commercial production.

Speakers from Europe, US, South America, and Australia will participate to provide a global picture of applications for this group of products.

Consultants/advisers, industry representatives and regulators will drive the conversation on what needs to happen to create user confidence and build a knowledge base on proper use of these technologies to achieve label claims. This is an opportunity to share your experiences with a diverse group of Ag professionals and to offer solutions on successfully incorporating these products into existing production systems. This workshop will be held on Tuesday, January 24th from 2:00 pm to 7:00 pm.

Efficacy Workshop

The goal of the efficacy workshop is to educate Contract Research Organizations on how to conduct good efficacy trials generating quality data. Each year, speakers from public and private research institutions are invited to share their knowledge with the audience.

The workshop usually covers trials conducted for multiple disciplines: entomology, acarology, nematology, plant pathology, weed management, and adjuvant research. Speakers address multiple topics from trial set-up to report writing. Depending

on trial discipline, different application, evaluation, and data collection methods are discussed.

The efficacy research workshop started in 2019 with a half-day program. Following increased participant interest and wide range of topics, the workshop format was extended to a full day including breakfast and lunch for the attendees. The format of the workshop was changed in 2021 due to COVID-19. The workshop that year was delivered in an online format as a part of the NAICC Academy. It is still available on the NAICC website.

On Monday January 23, 2023, NAICC will be hosting the 5th Efficacy Research Workshop focusing on how to conduct good efficacy trials to provide quality data. This workshop will be held between 8:00 am and 4:30 pm, with registration and continental breakfast beginning at 7:15 am.

The morning session will include lectures from our invited speakers whereas the afternoon session will be an interactive workshop. Invited speakers will share their knowledge about insecticide, fungicide, herbicide, and agronomic efficacy trial conduct focusing on row crops. The final program is coming soon.

The afternoon session with small group rotations will cover protocol writing, research trial problem solving scenarios, as well as a spray booth demonstration. Attendance certification and CEUs for CPCC-I, CPCC-R, CCA, PCAs will be provided at the end of the workshop. Pesticide applicator CEUs will be available for FL. The workshop cost is \$140.

We encourage contract researcher to give a short three to five minute talk to their peers about specific trial evaluation and application methods. For more information, please contact Anna Meszaros, chair of the Research and Education Committee (ameszaros@ufl.edu).


